16 October – POLYNESIAN AIRLINES NEW TWIN OTTER REGISTRATION



Polynesian Airlines New Twin Otter - 5W STF

Civil Aviation issued Certificate of Registration for 5W-STF which is Polynesian Airlines newly acquired Twin Otter.

17- 20 November Part 139 (Aerodromes) & Part 140 (AVIATION security) Annual Audits.

The Part 139 & 140 Annual Audits for the SAA was deferred to November due to a request from the certificate holder due to preparations for the SIDS Conference. The audits were conducted by PASO Aerodrome & Aviation Security Inspector Rob McIlelan and assisted by CAD staff. The Final Audit Report notes that the Certificate Holder is complaint.

20 – 21 November – Part 139 (AERODROMES) RECERTIFICATION AUDIT for Fagalii Airport

The Part 139 Recertification Audit was due in July 2014. Due to stagnation of negotiation between the SAA and Polynesian Airlines for the transfer of operational of Fagalii Airport back to the SAA, the Secretary for Transport decided to defer the Recertification Audit to December 2014. This decision was reached taking into consideration that the annual audit for this airport just been conducted in April 2014 and the costs savings to the current certificate holder.

The audif was conducted by PASO Aerodrome & Aviation Security Ibspector Rob McLellan and assisted by CAD staff. The Final Audif Report notes that the Certificate Holder is complaint and recommends Renewal of the CAR Pt.139 Certificate.

10 DECEMBER – PART 21 (CERTIFICATION OF PRODUCTS & PARTS)

LAUNCHING OF THE TRANSPORT SECTOR PLAN 2014-2019 ON 11 DECEMBER 2014



The Cabinet Development Committee endorsed the Transport Sector Plan (TSP) in its meeting in February 2014. The Transport Sector Plan 2014-2019 is a five year Plan which covers all

modes of transport including Sea, Air and Land Transport.

The development of the Transport Sector Plan (TSP) is one of the key economic infrastructures to support socio-economic development as articulated in the Strategy for the Development of Samoa (SDS) 2012 – 2016. The TSP is in two volumes with **Volume I** – outlining the main framework of action for the plan and **Volume II** – highlighting key analysis and trends used in formulating the TSP.

Honourable Minister of Works, Transport and Infrastructure, Afioga Manu'alesagalala Enokati Posala, delivered the key note address for the launch. This Plan is the first for Samoa and provides a coordinated planning framework that promotes a whole of Government perspective in the prioritisation and funding of investment in the transport sector for the next five years.

The TSP provides the necessary whole of sector framework to guide the development and funding of the sector in the next five years that is consistent with this general policy objective.

Vision of Transport Sector Plan

"Sustainable, safe, secure and environmentally responsible transport network that supports Samoa's economic and social development and contributes to improving the quality of life for all Samoans". There are five (5) Key Goals of the Transport Sector Plan

Goal 1: Strengthen transport sector governance framework;

Goal 2: Improve, sustain and climate proof road transport network;

Goal 3: Improve effectiveness, safety, security and competitiveness of maritime services:

Goal 4: Upgrade the capacity, safety and security of air transport services Goal 5: Ensure environmentally sustainable, energy efficient and socially responsible transport sector.

The Transport Sector Plan is administered by the Transport Sector Steering Committee which has been approved by Cabinet and the coordination is the prime responsibility of the Ministry of Works, Transport and Infrastructure under the Policy and Planning Division.
